One of the reviewers of this commentary called it a 'commentary you can read'. This new edition has tried to make it even more readable. Following two previous editions, it has now not only been revised stylistically but also shortened, in order to publish it in a single volume. The commentary's primary goal still applies, of course: renewal of the relationship between Christians and Jews, combined with a non-polemical, sympathetic and theologically deep-rooted perception of the Jewish people. This is in no sense an ideological narrowing, but rather is required by the text. The Gospel according to St John - like the other New Testament scriptures as well – is based on the Jewish Bible and arose in a Jewish context. To speak of 'Christianity' in the first century is simply anachronistic. In interpreting polemical statements made in an internal Jewish dispute, the commentary takes into account not only the situation in which they arose, but also the fact that our own situation today is substantially different from that. This prohibits a responsible interpretation from simply repeating statements that occur in such a context. More recent publications are also taken into account in the new edition, and fresh debate is sought particularly on passages in which contradictory interpretative approaches diverge.

The Letter to the Galatians is intended to resolve a conflict. New missionaries are spreading the view that one has to be circumcised in order to belong to God's people. Against this, Paul argues that through Jesus Christ, the son of Abraham and the son of God, and his sacrifice on the Cross, those who belong to him are also children of Abraham and at the same time children of God, and they are free from the Law. This view of the Gospel as representing freedom from the Biblical and Jewish Law went on to make history - often with anti-Jewish undertones. But in the Letter to the Galatians, Paul again advocates a very much wider understanding of the Hebrew Bible. On the basis of that understanding, he presses the view that devotion to Jesus Christ means liberation into a new life. In hermeneutic reflections and in a longer concluding section, the commentary enters into an engaging and critical discussion with the Pauline Gospel.

The Acts of the Apostles is the second part of St Luke's work and thus needs to be read with the same expectations that are already raised in the prologue, Luke 1.1-4: this is an educated member of a contemporary movement who is writing for an equally educated audience with an interest in the topic. It is about the story of God with Israel, which has entered a critical phase through Jesus of Nazareth, and about the resulting Jesus movement and its spread. The material is intended to make an appeal to readers that is just as existentially significant as it was to the first listeners to the missionary speeches reported in it. It is not a comprehensive historical narrative either temporally or geographically, but the Biblical author wants to go beyond mere hearsay and provide reliable information. Haacker comments on St Luke's text with philological tact and with informative insights into the way in which the Biblical texts are embedded in history.



Following the first volume, which described Buddhism in India, this volume discusses the historical and doctrinal development of Theravada Buddhism in its 'classical' homelands (Sri Lanka, Myanmar, Cambodia, Thailand and Laos), as well as its spread and revival in India, Bangladesh, Malaysia and Indonesia. The various schools of Tibetan Buddhism are also presented in detail and placed in the context of Tibetan history, and local forms of Tibetan Buddhism in Bhutan and among the ethnic groups of Mongolia are also described. A final chapter discusses Buddhism among the Turkic peoples of Central Asia before their conversion to Islam.

The final volume of this three-part work on Buddhism discusses the various schools of Mahayana in East Asia. The presentation of Buddhism in China and Japan naturally plays a major role here. A special aspect worth emphasizing is that the forms of Buddhism that developed in Vietnam and Korea are given independent chapters and are not treated merely as a marginal appendix to the influence of Chinese Buddhism on Vietnam, or with a reduction of Korea to being a mere conduit and mediator of Chinese Buddhism to Japan. Since various forms of Buddhism have also come to the West since the nineteenth century, an extensive chapter on Western Buddhism closes this multivolume religious history of Buddhism.

Theology and philosophy are faced with the task of recovering an appropriate concept of corporeality - not least in the face of challenges raised by our society's focus on the body and a 'corporeal turn' in many areas of science and scholarship. Decisive inspirations for gaining a theological perspective on the topic are drawn from Old Testament conceptions of the soul as corporeal and of the heart as having a capacity for orientation, as well as St Paul's principle that it is the body that gives salvation a location and a shape in secular reality. This investigation demonstrates the important place that corporeality has in the fields of anthropology, Christology and doctrine of God, epistemology and philosophy of religion. An ethics of corporeal existence and a body-based view of the person and human dignity are examined. Fresh light is also cast on the discussion of the mind-body problem. 

The closest connection between Jews and Christians probably lies in the fact that they share a common scriptural basis. All of the books of the Hebrew Scriptures (Tanach) are included in the 'Old Testament' of the Christian Bible. However, the history of Judaism and Christianity shows that the same books are understood and interpreted quite differently in each of the separate contexts. The new edition of this book emphasizes common ground and differences in understanding and interpretation and takes up the intensive hermeneutic debate that has been taking place over the last 20 years. This includes new findings on interrelationships between Judaism and Christianity in the first few centuries after Christ, as well as advances in Christian-Jewish dialogue. Special attention is given to the reorientation of the relationship with Judaism based on the Second Vatican Council, which led to a new understanding of the Old Testament in Catholic theology.

This textbook illustrates the 'History of Israel' from the beginnings until the Bar Kokhba revolt 132–135 AD. The history of the family is a well-researched cross-sectional field in social history and the history of mentalities. However, that is true only for the early modern period and modern history from 1789 to 1914, but not the twentieth century. Contemporary history of the family has so far been a field for family sociology, educational studies, and psychology. In this textbook, it is treated as a resource that needs to be developed through a dialogue between academic history and laypersons who are interested in family history.
