

There are three apparently contradictory aspects that define the religious features of South America: traditionally strong Catholicism, Protestant and Pentecostal denominations that have gained strength since the 19th century, and religions of pre-Columbian origin that have survived and developed further. This volume offers a descriptive account of these strands as the living religions of people today, which can be inquired into by ethnologists and religious scholars. In the process, the book divides South America into two religious areas: the Central Andes region, where pre-European traditions were already incorporated into local Christianity in many places during the colonial period, and the area east of the Andes (and to a lesser extent the northern and southern Andes), where separate religions survived more autonomously, but lost a large number of their adherents in the 20th century due to new, intensive Christian missionary work.



This commentary interprets the book of Amos as handed down in the Hebrew Bible: as a collection of the words of a prophet who emerges in the eighth century BCE and proclaims the end of the kingdom of Israel due to the social and ritual transgressions of its upper class, but in the end announces a safe future in abundant prosperity for survivors of the catastrophe from Judah and Israel. Diachronic analysis traces a path from the message of the eponymous prophet, which is recognizable only in outline, through the adaptations made by the first transmitters of the text following the end of the northern kingdom of Israel, to the final figure, who probably dates from the Persian era. Texts witnessing to the reception of the book - from other Old Testament writings to the present day - presented in highlights.



Significant parts of the text of Micah were probably written as part of a book of several prophets – or twelve prophets – and can therefore only be adequately understood and interpreted in that context. A piece of Old Testament theological history thus becomes visible here that was not primarily concerned with the message of a single, individual prophetic figure, but above all with general testimony to YHWH's speech and action in the history of his people. Zapff demonstrates this by reflecting diachronically on the results of a synchronic interpretation in order to trace the process of the creation of the text of Micah and its theological message.





This commentary shows the way in which Paul interprets the Torah for the Gentiles: concretely, realistically, sensitively, and argumentatively. He looks for images of a hope capable of withstanding death. He records the prayers and songs that were sung in the messianic communities of his time. And: he contradicts himself, particularly in his conception of what women should be like and in his factual dealings with them. The fact that the letter includes the notorious misogynistic sentences that were written in Paul's name is often the first association it calls up today. In addition, the letter is burdened by a long and prominent tradition of interpretation that used Paul to justify Christian positions of domination: the figure of Paul was used as a projection screen for Christian office-holders and their conceptions of domination over believers. Even more ominously, Paul epitomized a search for Christian identity by distinguishing it negatively from Judaism, which was regarded as a 'religion of the law'. A rediscovery of Paul is overdue. The interpretation is enduringly up-todate and represents the current state of international Pauline research. Luise Schottroff's interpretation of the letter makes it possible to develop different perspectives on the text and make them fruitful for one's own further research. Even five years after her death, she is an important teacher for those who are looking for their own critical and life-affirming approach to theology and exegesis.

Inspired by R. Bultmann's program of demythologization, this text inquires into the truth of mythical images in the Bible. It examines the various ways in which the Bible talks about God: narratively, dialogically, and doxologically, as well as ethically, mystically, and metaphysically. The Bible interprets Christological imagery as a kerygmatic message that leads to confrontation with God, as poetic imagination that seeks existential fulfilment, as a world of social symbols that creates sacred communal spaces. The 'demythologization' of this symbolic world starts with faith in the Holy Spirit: the cross reveals our distance from God, and the mystery of Easter renews God's nearness to us as a resonance in human beings through the Spirit. After 80 years, Bultmann's programme of demythologization is in this way renewed and continued kerygmatically and poetically, existentially and socially, cosmically and mystically. The transition from antiquity to the Middle Ages is still an enigmatic period in history. Too few documents from the time have survived. It was during this period, however, that the foundations were laid for the cultural and political entity we now call Europe. The transmitters of cultural values during those centuries accomplished a double feat: they saved the heritage of Greco-Roman antiquity from its final disappearance and, along with the new elements of the Judeo-Christian religion, passed it on to the fragmented and 'barbaric' peoples of the Celts and Germanic tribes. One of the men who stood out from the darkness of these centuries was Willibrord, who later became known as the 'Apostle of the Netherlands'. Only a few contemporary documents about his life and work have survived, and it is scarcely possible to obtain a well-rounded picture of his biography. However, a few highlights can provide glimpses into the enigmatic period in which the last of the Germanic tribes converted to Christianity, the advance of Islam ended and important foundations for Europe were laid. 

can recognize those facts. This introduction to metaethics explores the nature of morality. It illuminates morality from the points of view of philosophy of language, metaphysics, and epistemology. The book thus provides an overview of the various theories of metaethics. At the same time, it argues for a robust moral realism.
